Minutes of the Parish Council Meeting held on Monday 12 March 2012.

- Apologies were received from W.Atkinson and H.Garnett
 Members of the Council:- D.Collett (in chair), J.Carney, J.McPartlan
 G.Howard,D.Bastow and M.Harrison also attended.
 D.Collett advised with regret that D.Bastow would not be standing
 again at the next election, and he was thanked for all the dedicated work
 that he had done for the Council. However there were three seat vacant
 on the Council and it was hoped that some interest could be generated
 from the community.
- 2. Minutes of the last meeting held on 13 February having been circulated were taken as reed and approved as a true record of that meeting, proposed by J.Carney and seconded by J.McPartlan. The Chairman duly signed the minutes.
- 3. District councillors report. M.Harrison reported that he had asked that 6.92.302.FUL at 36, Brookfield Crescent be seen by the Planning Committee. A discussion took place about the extra litter bin that had been requested at the end of St Thomas A Beckett Way. M.Harrison suggested that evidence be supplied that showed a litter problem and a map pin pointing where the bin was requested. He would then take up the matter with Environmental Services
- 4. County Councillors report. None given. Councillors agreed that a memo should be sent to H.Garnett regarding a response to the 20mph limit for the village. Also replies were required the response regarding the suggestion to divert the Nidderdale Way footpath from the Birstwith Road. Priority should now be given to this following a traffic accident at Clapham Green close to the footpath.

- e. Two Ridings Community Group. D.Bastow was to ask if he could remain the Parish Council representative despite resigning from the Council.
- f. Recreational & Sporting Facilities. The work to improve the facilities was ongoing. The Council were awaiting the funding from WREN to enable them to pay the contractors. Thanks were given to G. Howard for all the work he had done to enable these improvements to take place.
- g. Feast Report. The plans for the Feast on 21/22 July are being arranged.
- h. Footpaths. W. Atkinson and D. Bastow are to discuss the footpaths, and J. Carney also offered his support.
- i. Village Society. No report.
- j. Village Plan Group. No progress yet on Broadband. It was suggested a life belt for the River Nidd be provided as part of the Community Resilience Plan.

8. Planning applications

- a. 6.92.113.C.FUL, 1 storey extension at Spring Garth, High Street. No objections.
- b. 6.92.119.F.COU, change of use of car showroom to antique furniture at Brookroyd Garage. No objections.
- c. 6.92.209.D.FUL, 1 storey extension at Rose Lawns 38, Hollins Lane. No objections
- d. 6.92.303.TPO, deadwooding of 1 oak tree T1 and deadwooding and crown lift to 6m of 1 ash tree T£ of TPO 28.2008 in land comprising field west of Brookfield Way, Brookfield Crescent. Councillors wanted reassurance that work would not damage the trees and asked that the arboricultural officer oversee the work.
