3. Traffic and Parking in the Village.

A report from the Village Plan group

Councillors agreed that the survey carried out by J.McPartlan was approved and should be sent to Area6Boroughbridge following some adjustments made to the format by G.Howard. J.McPartlan was thanked for his work.

P.Parker had been asked to draft a letter to NYCC and D.Collett was to contact D.Bowe regarding the previous promises made before the letter could be sent. Proposed yellow lines from Sofie's to Bower's premises. This was to be requested as a separate item.

Car parking. Some enquiries had been made regarding suitable sites and some options discussed. Councillors agreed that G.Howard forward his report on site locations bearing in mind the possible location for building on the Brookfield site. R.Binns was to speak to School about a possible path to the Cricket pavilion.

Memorial Hall .A suggestion that the garage vehicles that were parked at the front of the building be relocated to the rear. (Only those with the permitted permits.)

The future of Saddlers Cottage was also discussed and D.Collett was to make some enquiries.

- b. Memorial Hall. Meeting held on 2 December. Items raised:- new gate posts installed, permits for Garage vehicles parking, new commemorative plaque to be installed in New Year,new solar panels not yet installed,& car parks to be relaid. Complaints had been received about noise following events.
- c. Safer Neighbourhood Group. Councillors were asked to be aware of scrap dealers operating in the area.

- e. Recreational and Sporting facilities. Backhouse Bros were to continue levelling the bund in the Feast Field soon. M.Fletcher was to continue talking to residents whose land abutted the Feast Field regarding the letter from NYCC to the Council, and the letter that was sent residents, regarding the closing up of any access points from their property to the field.
- f. Feast Group. A change of treasurer was to take place.
- g. Village Society. They were unable to carry out any works on the Medieval Way. They had paid for the new gate posts at the Memorial Hall and the work on the commemorative plaque for the Hall. D.Collett had asked Horizon Life if they would be able to assist in any work that was necessary on the Medieval Way, to which they agreed. J.Carney and M.Fletcher were to carry out some survey work to find out where the paving stones were laid originally.
- h. Footpaths. The big stones had been removed on the Beckside to Football Field footpath. M Guerney from NYCC was to contact M.Fletcher regarding other footpath items that included the kissing gate query.
