Again Councillors reiterated that there was sufficient room on the pavement to allow access by pushchair/wheelchair, if bollards were installed to stop vehicles driving on to the pavement.

Footpaths. The footpath near the Cricket Club has been resurfaced up to the bridge but further work needs to be done. There are no officers responsible for supervising future work on footpaths at NYCC. The access past Cruet Farm has still not been resolved.

10. Matters raised by Councillors

A tree is obstructing the street light near the Methodist Church A street light is going out under the NYCC savings scheme on power. The map of highway lights that is covered under this scheme is to be surveyed by Councillors.

The flooding in a resident's garden had been caused by a field drain in the field belonging to a local landowner and they are responsible for this drain. HBC are to investigate this problem.

A new volunteer key holder for the Bus Shelter is to be found. Should Councillors be represented at the Remembrance Service? The Church Service is cancelled.
