- 2. Minutes of the last meeting held on 10 April 2017, having been circulated were taken as read and being a true record of that meeting subject to a minor amendment to read "Core Coach" instead of Pro Coach, proposed by J.Fairfoot and seconded by by M.Wray. The Chairman duly signed the minutes.

3. Traffic Issues.

95 Alive has responded regarding speeding on Hollins Lane and Church Lane. The Police are analysing the records and will report on the findings. Yellow lines on the corner of Birsthwith Road and High Street. The new owner of Laurel Cottage and Mr Bowers have no objections. D.Collett suggested that the proposed yellow lines could now be progressed.

Hedge on the corner of Hollins Lane and Brookfield. Some work has been done to cut back the hedge on the instructions of NYCC. A meeting is to be held between Highways and the resident as sight lines are still not adequate.

Cricket Club extra car parking provision. M.Wray has spoken to the landowner about improving the area with a hard standing to encourage car parking to ease congestion in the village. Councillors approved the idea of a written agreement between the land owner and Council would help to secure funding for the scheme. J.Backhouse,J.Fairfoot, M.Wray and G.Howard are to liaise regardingpossible grants.

4. District and County Councillors Report.

M.Harrison has been elected for four years as County Councillor . He is to take a Councillor position as representative for Health and Adult services. HBC are to move to the new premises at Knapping Mount scheduled for completion in September. Meanwhile the existing premises are being sold for various uses including an Art Gallery, tea room, other mixed use and business uses. The proposed rent increase on the Feast Field is still under review with NYCC.
