## **REFUSAL OF PLANNING PERMISSION.**

The reasons for the decision are as follows:

## Page 3 of 6

1 The proposed development by reason of its edge of settlement location and scale will result in a significant expansion of the village into the surrounding rural landscape, adversely impacting the setting of the Hampsthwaite Conservation Area, the setting of grade II listed buildings and nondesignated heritage assets located within the Conservation Area and the landscape setting of the Nidderdale Area of Outstanding Natural Beauty. Therefore, the proposal is contrary to Policy EQ2 of the Harrogate District Core Strategy, Policies C2 and HD3 of the Harrogate District Local Plan and Sections 16 and 72 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

2 No overriding justification exists for the development of a medical centre on land that is within Flood Zone 2 in conflict with Policy EQ1 of the Harrogate District Core Strategy.

3 Inadequate evidence has been provided to demonstrate whether significant ecological harm is caused by the development or that appropriate mitigation is available if necessary.

Therefore, the proposal is in conflict with paragraph 175 of the National Planning Policy Framework.
