REFUSED. Reason(s) for refusal: -

1 The site falls within Flood Zone 3 and the Council considers that reasonably available alternative sites exist within Flood Zone 1 capable of accommodating the proposed development with the wider locality. The proposal is therefore inappropriate development in conflicts with Paragraph 2 of the Technical Guidance to the National Planning Policy Framework.

The proposed development lies beyond the development limit for Hampsthwaite set out in the emerging Harrogate District Local Plan and will harmfully affect the setting of the Church of St Thomas a Becket, a Grade II listed building, the setting of several buildings on Church Lane which are non-designated heritage assets and the character and appearance of Hampsthwaite Conservation Area contrary to Policies EQ2 and SG4 of the Harrogate District Core Strategy Development Plan Document, Policy HD3 of the Harrogate District Local Plan and Sections 16 and 72 of the Planning (Listed Buildings and Conservation Areas) Act 1990.
