Limited of the one part and the Granter of the other part and thereon coloured pink and surrounded by a red line TOGETHER with such right or interest as the Grantor may have in the misce of land referred to in a Deed of Dedication acted the Eighth day of December One thousand nine hundred and thirty-eight and made between the sold John Smith Tedcoster Brewery Co. Limited of the one part and the Jounty Council of the West Riding of Workshire of the other part but SUBJECT as therein mentioned AND SUBJECT ALSO to the covenants mentioned contained or referred to in the said Deed of Exchange so far as the same relate to or effect the property hereby conveyed and are still subsisting and capable of being enforced TO UCLD the same (subject as aforesaid) UNTO the Council in fee simple UPON THE TRUSTS and SUBJECT to the powers and provisions set out in the First Schedule Fereto-THE Council hereby covenants and agrees with the Grantor that the

THE parties hereto hereby certify that the transaction hereby effected does not form part of a larger transaction or of a series of transactions in respect of which the amount or value or the aggregate amount or value of the property conveyed or transferred exceeds Five hundred pounds. .. The property hereby conveyed (herein called "the Trust Premises") shell be held upon trust for the purposes of physical and mental training. and recreation and social moral and intellectual development through the medium of resding and recreation rooms library lectures classes recreations and entertainments or otherwise as may be found expedient for the benefit of the inhabitants of the Parish of Fampsthweite in the County of York and its immediate vicinity without distinction of sex or of political religious or other opinions subject to the provisions of these presents. The general management and control of the Trust Fre ises and the Arrangements for their use shell be vested in a Committee of Management (here nafter called "the Committee") consisting of not more than Twentyfive members (exclusive of members co-opted under the power hereinafter contained) of whom eight shall be elected at the Sixth general meetin. referred to in Clause 3 hereof in the first instance and on each subsequent appointment of members at the Annual General Meeting The organisation mentioned in the second column of the Second Schedule hereto shall each have the right to appoint one member of the Committee both in the first instance and on the occasion of each annual a mointment of members. The persons whose names anyear in the first column of the Second Schedule herete have been appointed by the organisation mentioned opposite their respective names in the second column of that schedule and shall together with the members elected at the Sixth General Meeting as aforesaid be

the first members of the Committee. Until the Sixth General Meeting has been held the persons named in the first column of the Second Schedule shall have power to act. In addition to the members of the Committee appointed and elected as above the Committee shall have the power to co-opt not more than three members to represent interests in the said Parish not represented by any organisations

There shall be an Annual General Meeting to be convened by the Committee in the month of March in each year the sixth of such meetings (herein called "the Sixth General Meeting") to be convened in the month of March One thousand nine hundred and fifty-three (five Annual Ceneral Meetings having already been held on the Seventeenth day of December One thousand nine hundred and forty-six Twenty-eighth day of January One thousand nine hundred and forty-eight Twenty-eighth day of February One thousand nine hundred and forty-nine Eighth day of Movember One thousand nine hundred and fifty and First day of September One thousand nine hundred and fifty-two) by one week's notice to be affixed to some conspicuous part of the Trust remises or other conspicuous place or places in the Parish of the inhabitants of the age of eighteen years or upwords of either sex of the Parish of Hampsthwaite for the purpose of receiving the Report and Accounts of the Committee and for accepting the rest mation of members of the Committee and for the purpose of electing eight members under Clause 2 hereof and for taking such action as it may decide under Clause 7 hereof, provided nevertheless that if in any year an annual General Meeting shall not be convened and held in the month of March the Annual General Meeting for the year shall be held as soon as practicable after the month of March and such meeting shall be convened by such persons as shall be nominated for the purpose by the Ministry of Education_

4. All members of the Committee shall retire annually at the Annual General Meeting. Every organisation entitled to appoint a member of the Committee to take the place of a member retiring at an Annual General Meeting shall make the appointment at any time within one month before the Annual General Meeting at which the retiring member of the Committee shall retire.

5. A casual vacancy arising from the death or resignation or removal of an appointed member of the Committee shall be filled by the organisation by which such member shall have been appointed and the person so appointed shall retire at the time when the vacating member would have retired. In the event of a vacancy arising through the death resignation or removal of a member of the Committee elected by the annual General Meeting the Committee shall have power to fill such vacancy
