

## HAMPSTHWAITE PARISH COUNCIL

Minutes of the Parish Council Meeting held on Monday 13 November 2017.  
At 7.30pm, in the Village Room.

1. Apologies from J.Fairfoot, & M.Wray.  
Members of the Council:- D.Collett (in chair), J.Backhouse, J.Carney, H.Brown, G.Howard. M.Harrison also attended.
2. Minutes of the last meeting held on 16 October having been circulated were taken as read and a true record of that meeting proposed by J.Backhouse and seconded by G.Howard. The Chairman duly signed the minutes.
3. Traffic Issues. No progress. A meeting at Darley Memorial Hall to meet the Highways team will be attended by J.Carney and G.Howard.
4. District & County Councillors Report  
NYCC will be replacing street lighting with LED lights that have a life of 20 years and reduce electricity cost and maintenance costs.  
HBC have taken possession of the new building at Knapping Mount but it is not yet open to the public.  
Using an NYCC to report a defect on Highways using the “on line reporting” has resulted in work being done quickly.
5. LDF for Rural Areas.  
Action Groups have been formed in the area and are working together.  
A discussion between M.Harrison and Councillors about the various sites proposed by developers in the area took place. Some of the areas proposed have not reached the stage of actual applications and some of the areas are not preferred sites in the proposed new Local Plan.

G.Howard reported that he has painted the parts of the Feast bridge prior to work being carried out to replace damaged/rotted timber later.

*Feast Group.* The group have now adopted the Hampsthwaite Show which will be named Team Show and form part of the subgroup of the Feast Group.

The decision to amalgamate the two groups will result in the future name of the Annual Feast to the Hampsthwaite Feast & Feast Show. This was approved by the two groups. The next Film Show will be on Saturday 18 November 2017 at the Memorial Hall at 7.30pm.

Disproportionate size for the proposed development. Close proximity to adjoining property that would lead to loss of amenity. Over intensive development in a garden creating a new dwelling.

b. 17/04809/FUL, single and two storey extensions, dormers and gable roof and alterations to fenestration at 22 Hollins Close for Mr & Mrs Peters.
