- By a Deed of Appointment dated the Thirtieth day of December (2)One thousand nine hundred and sixty six and made between the said Joseph Allan Hardcastle John Bellerby the said Harry Swires and Thomas Hobkinson of the one part and the said Clifford Wilfrid Yeadon the said Ben Hardcastle the said Marian Hardcastle the said John Frankland the said Nellie Baren George Robert Cundall Kathleen Mary Brown Richard Gordon Baren and Enoch Bradley of the other part the said Joseph Allan Hardcastle John Bellerby Harry Swires Thomas Hobkinson Clifford Wilfrid Yeadon Ben Hardcastle Marian Hardcastle John Frankland Nellie Baren George Robert Cundall Kathleen Mary Brown Richard Gordon Baren and Enoch Bradley were appointed to be the trustees of the said Conveyance dated the Second day of December One thousand nine hundred and thirty. - (4) By a Resolution of a Special Meeting of the said Mission it was duly resolved that the trust property be transferred for an estate in fee simple in possession free from incumbrances and the Vendors were instructed by the Managing Trustees to convey the same to the Board
- (5) This Deed has been approved and ordered to be executed by a Resolution duly passed at a duly constituted meeting of the Vendors and it is intended to be executed by two of the Vendors upon whom the Vendors acting under Section 34 of The Charities Act 1960 have duly conferred a general authority to execute in the names and on behalf of the Vendors all assurances and other deeds and instruments
- (6) This Deed has been approved and ordered to be executed by a Resolution duly passed at a duly constituted meeting of the Managing Trustees and it is intended to be executed by two of the Managing Trustees upon whom the Managing Trustees acting under Section 34 of The Charities Act 1960 have duly conferred a general authority to execute in the names and on behalf of the Managing Trustees all assurances and other deeds and instruments



- 4. IT IS HEREBY CERTIFIED that the transaction hereby effected does not form part of a larger transaction or of a series of transactions in respect of which the amount or value or the aggregate amount or value of the property transferred exceeds Twenty five thousand pounds
